For the marketing analysis we chose 15% of the most popular web shops from CZ list of shops. The shops without prices for products and shops which provide just bulk/wholesale order were removed from our selection. In addition another 6 web shops, previously chosen for the purchase of substances, were added to the marketing analysis. The final number of web shops used for analysis was 11. For latter analysis, we use only shops where product was available.
